Minutes of the meeting of the Board of Trustees of Westchester Community College held on Wednesday, December 11, 2024, at 3 PM in the Student Center Event Room.

Call to Order

INFORMATION AND DECISION

A. President's Report

Dr. Belinda S. Miles reported:

Completion Ceremony

- Tomorrow, we celebrate August and December 2024 graduates at our annual Completion Ceremony (4 PM, Physical Education Building.)
- 225 students graduated in August 2024 and to date, 419 have applied for December graduation.
- Appreciate Board Chair, Dr. LeRoy Mitchell joining the ceremony and offering greetings to students and their guests.

Student Excellence – Bridges to the Baccalaureate Research Training Program:

 I am very proud to share that students David Pinto and Christian Neves were selected as T34 Bridges Scholars as part of the Bridges to the Baccalaureate Research Training Program at Binghamton University. The program provides support to full-time underrepresented community college students from SUNY WCC, Monroe Community College, and Onondaga Community College and helps prepare them for transfer from community college to Binghamton University to complete a baccalaureate degree in biomedical science.

Faculty Excellence

- Professor Nicole Tschampel (Photography and Digital Filmmaking) has been named a fellow for the inaugural 2025 cohort of the SUNY Accessibility Advocates and Allies (AAA) Faculty Fellowship Program – a community of faculty leaders committed to promoting and growing accessibility practices in and out of the classroom on their campuses.
- Professor Megan Moore (Veterinary Technology) has been named as an inaugural Fellow of the Association of Veterinary Technician Educators (AVTE), a program recognizing "individuals who have shown a profound commitment to advancing the veterinary technician profession through leadership, mentorship, and innovation."

Institutional Excellence

 I was honored to join Dr. Glenetta Phillips and Professor Blakeley Lowry at Wartburg Rehabilitation Center's Volunteer and Partnership Recognition Luncheon last week where SUNY Westchester Community College was named their 2024 Community Partner of the Year. Wartburg extends internships to our current students and employment opportunities for our graduating students. Our students can complete their Healthcare Practicum Internships, work alongside healthcare professionals, and apply classroom knowledge to skills learned during their experiential learning opportunity at Wartburg. According to Kerry Minto, Wartburg's director of Institutional Advancement and Volunteerism, our "talented students have enriched our Adult Day, Assisted Living, and Rehab programs... Their involvement in key events, research, and initiatives... has made a lasting impact."

Enrollment Management

- Enrollment for Winter 2025 and Spring 2025 is well underway. Instruction begins 12/23.
- Currently, 731 students are registered for Winter 2025, reflecting an increase of 11.3% compared to Winter 2024.
- For Spring 2025, 7,157 students have registered, with a total of 1,983 FTEs.
- Offering four sessions: 15-week (instruction begins 1/21); two 7.5-week sessions (instruction begins 1/21 and 3/25); and 12-week (instruction begins 2/11).

Strategic Planning Update

• The Strategic Planning Committee will meet on Friday (12/13) to discuss the findings collected during their information gathering process. The Committee will be drafting a one-page Strategic Plan draft and will be setting a calendar and deadlines for the Spring. The draft plan will be discussed at length with senior administration, Board of Trustees, and wider college community for their review, edits, and suggestions.

MSCHE Update

• Administrative units are on target to meet a mid-December deadline for providing their 2024-25 mission, goals, objectives, and data methods. Middle States mandates that each department of the College submit this information annually, and a small campus review team will provide feedback to the departments on their submissions. In Spring '25, the departments will measure how well they have done in meeting their objectives and submit an annual report outlining their results and what they have learned. This information will be used both to inform the following year's goals as well as provide strategic institutional insight regarding the administration of the College.

In closing and as we bring the semester and 2024 to a close, I extend thanks to our faculty and staff for helping students achieve their goals and to our Board members and the Cabinet for their diligent and focused service to the college.

B. Board Chair's Report

Trustee Mitchell reported:

New York Community College Trustees (NYCCT) and the Chancellor had a disagreement regarding who has the responsibilities of hiring college presidents.

The New York State Association of Counties (NYSAC) has written a letter supporting the Community College Trustees.

Dear Chancellor John B. King, Jr.:

For nearly seventy-five years, New York's community colleges have distinguished themselves by meeting the educational needs of sixty counties through a model that emphasizes affordability, vocational training, and seamless transfer pathways to four-year SUNY institutions and private colleges. This decentralized system was intentionally designed to foster a partnership between the state, local communities, and SUNY, with counties serving as essential sponsors responsible for funding a significant share of the colleges' operational costs and infrastructure needs. Community colleges are, by their very nature, locally governed institutions within the SUNY system, and for over seven decades, they have exercised autonomy over essential operating decisions. This governance model has allowed local boards of trustees the flexibility to address unique community needs, from the appointment of college presidents and performance reviews of college leadership to contract negotiations and other critical governace matters. This autonomy has been foundational to the community colleges' success and vital to their local missions. Historically, in the event of a presidential vacancy, the local board of trustees has been entrusted to conduct an independent search process, culminating in a single nomination for the Chancellor's endorsement and SUNY Board of Trustees' final approval. This balanced approach respects both the local insight of trustees and the oversight role of the SUNY system. However, recent centralizing actions by the SUNY Chancellor and SUNY System Administration constitute an alarming overreach, undermining the autonomy of community colleges and disrupting the finely tuned balance among the supporting stakeholders. Such interventions threaten to erode the local governance model that has been crucial to the success of community colleges, alienating local trustees and diminishing counties' roles as sponsors

More specifically, SUNY Board of Trustees Resolution, dated November 12, 2024, and affecting community college presidential appointments and contracting, is an unlawful attempt by SUNY, through its own forced policy change rather than legislation by the New York State Legislature, to exercise control over each local community college appointing and contracting with its president. During the SUNY Board of Trustees meeting held on November 12, 2024, you stated in support of the Resolution that "I know that this Board believes one of its important responsibilities is to appoint campus presidents." This statement in support is wholly inconsistent with Education Law Section 6306, which grants the board of trustee of each community college, not SUNY, the authority to appoint a president for such community college.

On behalf of the New York State Association of Counties (NYSAC) and all county governments, we unequivocally support the continued authority of local community colleges over all operational decisions. We call for the reaffirmation of the longstanding practice whereby community colleges make their own decisions regarding the appointment of presidents, performance evaluations, faculty and staff contracts, and other governance matters essential to their missions. Toward this end, while each community college board of trustees will make its own decision whether to participate in the presidential search pilot project and new presidential contracting procedure purportedly adopted by SUNY under the Resolution, NYSAC will not encourage its members who sponsor community colleges to do so.

To preserve the integrity of community colleges and their ability to serve their communities effectively, we urge SUNY to recommit to the principles of local governance that have historically served New York well by rescinding the Resolution as soon as possible so that current and future community college presidential appointments and contracting may continue under the partnership in place between the state, local communities and SUNY prior to the Resolution.
